In the face of declining boat ownership and economic

and budgetary restrictions we have a significant challenge before us, but there is a bright side.

More people today are interested in becoming involved in the Auxiliary. There is a spirit of patriotism that we have not seen for some time. I deeply appreciate the efforts that Whit Vick, Cris Vonderheide and Bob Funk have made to provide 14-8 with an on the water presence but they need help. Neill Thaggard is committed to the process of crew and coxswain in 2010 and Charles Smith has accepted the challenge of **Ten in Ten**.

We will accomplish this goal, with your help.

Protecting Your Computer Against A New Wave Of Malicious Software Attacks

Since the first of February, I have had a record number of computers come in my shop with the same virus infection. This particular infection looks like a computer security message and easily dupes the computer user into installing a phony anti-virus program which holds the computer hostage until the user pays to repair non-existent problems. I suspect that this computer infection is transmitted thru infected Adobe PDF files on Windows XP. Since the Auxiliary uses these files and the Adobe Reader program

extensively, it is important that you know how to protect your computer from this infection.

- 1. Make sure that your Windows program is up to date. Windows XP has a security feature called "Automatic Updates" This should be turned on, and you should always allow Windows Updates to install when you receive requests that you install them.
- 2. You should have the latest version of Adobe Reader installed on your computer. The latest version is Adobe Reader 9.3. This is easily downloaded and installed from www.Adobe.com
- 3. JAVA is a program widely used to deliver internet content to your computer this needs to be up to date as well. If your computer asks you to update JAVA allow it to do that update. You can manually update JAVA from the Windows XP "Control Panel" under the JAVA icon.
- 4. Make sure that you have a properly working Anti-Virus Program and that it updates itself automatically. Free Anti-Virus programs are available at www.download.com. I recommend brands AVG, Avast, and Avira. All of these offer free virus protection without slowing down your computer's operation. (Make sure you install the "free" version when choosing one of these programs)

Introducing Sector Jacksonville Commander Andy Blomme Captain U. S. COAST GUARD

Captain Andy Blomme reports to Sector Jacksonville having recently completed a three-year assignment as Military Assistant to the Secretary of Homeland Security. In this position Captain Blomme was honored to serve both Secretary Michael Chertoff and Secretary Janet Napolitano and traveled throughout the United States and around the world in fulfilling his duties.

Previous command tours have included the Coast Guard Cutter DILIGENCE, a 210' medium endurance cutter homeported in Wilmington, NC, Cutter NANTUCKET, a 110' patrol boat homeported in Roosevelt Roads, Puerto Rico and Key West, FL and Cutter POINT HURON, an 82' patrol boat homeported in Little Creek, VA. Captain Blomme rounded out his nearly twelve years of sea duty with tours aboard Cutter GALLATIN in Governors Island, NY and Cutter CHASE in San Diego, CA. Additional operational tours included three years as a controller in the Coast Guard's Fifth District Command Center in Portsmouth, VA and three years as the Operations Officer at Coast Guard Group Miami.

A 1985 graduate of the US Coast Guard Academy and a 2001 graduate of the U. S. Army Command and General Staff College, Captain Blomme holds Masters degrees from Central Michigan University and the Marine Corps War College. His military awards include the Meritorious Service Medal (3 awards), Coast Guard Commendation Medal (5 awards), the Coast Guard Achievement Medal and the Commandant's Letter of Commendation (2 awards).

Captain Blomme is married to Peg Blomme, a Captain in the Coast Guard Reserve, and they have two sons. Alex will be a freshman at the University of North Carolina this fall and Matthew will be entering seventh grade.
